It represents an attempt to extract those laws and rules of particular interest to Maine physicians from the thirty-nine titles of Maine statutory law, the ever increasing regulations promulgated by various state agencies, applicable federal law, and the Current Opinions of the American Medical Association's Council on Ethical and Judicial Affairs. In some instances, excerpts from the statute or regulation have been quoted. In other cases, the relevant material has been paraphrased.

State laws passed through March 2008 have been included, although some major developments since that time have also been added and continuing updates will be made available only through the online version under the members section.

Since amendments to state law occur frequently, and excerpts can be misinterpreted when viewed in isolation, the full text of a relevant statute or rule must sometimes be consulted. Members are advised to consult with an MMA attorney or attorney knowledgeable in health care law for answers to specific questions.

The Association hopes that this booklet will be a ready and valuable reference for your practice.
