I. The committee members expressed hope that this total will increase this year. The donations raised this year will go primarily to the MMET Scholarship Fund and apply towards the match proposed by Dr. Linder. Some donations will likely be earmarked for the Dalco Fund as they were last year.</p>	<p>Informational</p> <p>Dee will prepare the notice to be distributed and work with MMA staff to market the event and solicit donations.</p>
III. Stred building re-dedication on 8-24-11	<p>The Stred Building Re-Dedication is planned for Wednesday, August 24th from 11am – 2pm. The proceeds from this event will benefit the COMFORT Fund and be specifically directed to the Stred building maintenance needs. Gordon confirmed that Mrs. Stred and at least one daughter will be joining us for a re-dedication of the MMA building, which will include the unveiling of a photograph and plaque in the upstairs lobby.</p> <p>A host committee including some key physicians that Mr. Stred worked with, along with many of MMA's past presidents has been formed and includes Fred Holler MD and Robert McAfee MD, (as co-chairs), along with John Towne MD, Richard Leck MD, Patti Bergeron, and friends Tony Bates DMD, the Hezelton's and Peter Thompson. The role of the host committee is to welcome guests during the event and encourage other physicians to attend. The staff will work with the committee to identify those in the community at large that benefited from Mr. Stred's work and might be willing to make a donation in his honor.
